- ELIGIBILITY** Entry is open to women amateur golfers who are legal residents of Illinois and have an established USGA 18-hole handicap index of 28 or less and whose club or association is a member of the IWGA. A player whose club is not a member of the IWGA may elect to become an individual member of the IWGA for a cost of \$15.
- ENTRY DEADLINE** Entries will be accepted from the applicants with the lowest handicaps until May 29, 2010 or until the field of 80 players is full. Confirmation of receipt of entry and payment will be mailed. In the event of a full field, applicants will be notified if they have been placed on the waiting list.
- FORMAT** The tournament format is match play with flights determined by an 18-hole qualifying round on Tuesday. Championship Flight will be comprised of 32 players with remaining flights comprised of 8 players. The defending champion is exempt from qualifying and will be seeded number one. The defending champion may elect to play the qualifying round to compete for Medalist honors. Her seeding will not be affected. If two or more players tie for the last place in Championship Flight, placement into Championship flight will be determined by sudden-death playoff. Any player not on the grounds at the time of such playoff will forfeit her rights to Championship Flight. All other ties will be determined by scorecard return sequence.
- PRIZES** Prizes will be awarded to the winner and runner-up in all flights in addition to semi-finalists in Championship Flight. Qualifying round prizes will be awarded for Medalist, Jr. Medalist, low net team, long drive, and the Young-at-Heart Trophy for those over 50.
- ENTRY FEE** The entry fee is \$130 and includes a practice round on Monday, June 7, tournament rounds, tournament round warm-up balls, prizes, and Tuesday night dinner. Tuesday dinner guests are welcome at a cost of \$35. Refunds for cancellations prior to May 29 will have a \$10 administrative fee deducted. No refunds will be given after May 29.
- CONTESTANTS** A contestant may use a caddie, drive or have her caddie drive a motorized cart, or carry or pull her own clubs. Proper golf attire must be worn. Blue jeans, halter tops and tank tops are not permitted. Soft spikes only. Electronic devices that measure distance only will be allowed.
- REGISTRATION** All contestants must register in person or by phone at (708) 798-4700 on Monday, June 7, from 11 am to 3 pm. Contestants are requested to present current handicap card.
- PRACTICE TEE TIMES** Monday practice round tee times can be arranged with the Pro Shop at (708) 798-4700. Tee times for the qualifying round will be in order of handicap index. Times will be available at the clubhouse and on-line at [www.iwga.org](http://www.iwga.org) after 6pm on Monday, June 7. Pairings for match play will be available as soon as possible following the qualifying round.

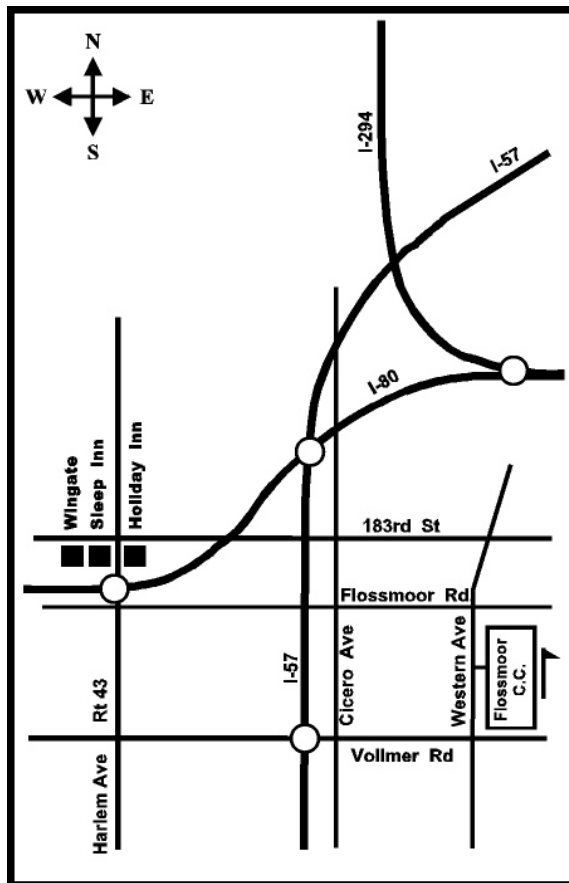
